 - b) Hand in a physical copy of the signed form to Stephen Niamke or his designee. Contact Stephen at chair@roanokedems.com to arrange pickup, or deliver it to the Full Committee meeting on Thursday, January 18, 2018, 6:00pm at the Grandin Co-Lab, 1327 Grandin Rd SW, Roanoke, VA 24015.
 - c) A committee member will be available in the lobby of the Noel C. Taylor Building in Roanoke, VA from 4:00pm - 5:00pm on Wednesday, January 31, 2018 to accept forms in person.
- 4) Emailed copies of the form must be time-stamped by 5:00pm, Wednesday, January 31, 2018.
- 5) Hand delivered forms must be received no later than 5:00pm, Wednesday, January 31, 2018.
- 6) A Filing Fee must be paid by 5:00pm, Wednesday, January 31, 2018. The Filing Fee will be detailed in the Call to Caucus. The Filing Fee can be paid by one of these methods:
 - a) Handing a check in person to Stephen Niamke using the methods above (see 3).
 - b) Submitting a payment to:

 - i) A 4% surcharge will be required for those paying electronically.
- 7) The Unassembled Caucus (Firehouse Primary) will be held on Saturday, February 10, 2018. The Time, Location and Filing Fees will be listed in the Call to Caucus, to be announced on Wednesday, January 24, 2018.
- 8) There are three (3) seats available for nomination. If no more than three candidates file by the deadline, the Firehouse Primary will be cancelled and filing fees returned to the candidates.
